BERIKUTAN penyiaran Notis Penentuan Muktamad Afirmatif bagi Kajian Semula Pentadbiran Duti Anti-Lambakan berkenaan dengan Import Keluli Tahan Karat Gulungan Sejuk Dalam Bentuk Gegelung, Kepingan atau Apa-Apa Bentuk Lain yang Berasal atau Dieksport dari Republik Rakyat China, Republik Korea, *Chinese Taipei* dan Thailand [*P.U. (B) 290/2023*] dalam *Warta* pada 25 Julai 2023, Kerajaan telah mendapat maklumat bagi kajian semula pentadbiran dijalankan terhadap pengenaan duti anti-lambakan berkenaan dengan import keluli tahan karat gulungan sejuk dalam bentuk gegelung, kepingan atau apa-apa bentuk lain dengan ketebalan antara 0.3 milimeter hingga 6.5 milimeter dan kelebaran tidak lebih daripada 1,600 milimeter, tidak termasuk—

- (a) keluli tahan karat gulungan sejuk dengan kemasan sepuh lindap berkilat (BA), No. 8 (Kemasan Cermin), timbul, keras, gores atau berwarna; atau
- (b) keluli tahan karat gulungan sejuk dengan nilai kekerasan melebihi 250HV,

yang berasal atau dieksport dari Republik Rakyat China, Republik Korea, *Chinese Taipei* dan Thailand (“dagangan subjek”) dan menurut perenggan 28(1)(c) dan (f) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan peraturan 34 Peraturan-Peraturan Duti Timbal Balas dan Anti-Lambakan 1994 [*P.U. (A) 233/1994*], Kerajaan memulakan suatu kajian semula pentadbiran terhadap pengenaan duti anti-lambakan atas dagangan subjek itu.

Dagangan subjek

2. (1) Dagangan subjek dikelaskan di bawah Kod Sistem yang Diharmonikan (“Kod H.S.”) dan Tatanama Tarif Berharmonis ASEAN (“AHTN”) 7219.31.00 00,

7219.32.00 00, 7219.33.00 00, 7219.34.00 00, 7219.35.00 00, 7220.20.10 00 dan 7220.20.90 00.

(2) Kod H.S. dan AHTN yang dinyatakan dalam subperenggan (1) diberikan hanya untuk maklumat dan tidak mempunyai kesan mengikat terhadap penjenisan dagangan subjek.

Duti anti-lambakan sedia ada

3. Duti anti-lambakan yang berkuat kuasa pada masa ini bagi dagangan subjek ialah duti anti-lambakan definitif yang dikenakan di bawah Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) 2023 [*P.U. (A) 225/2023*].

Alasan bagi kajian semula pentadbiran

4. (1) Kajian semula pentadbiran itu dimulakan berdasarkan alasan bahawa syarikat Bahru Stainless Sdn. Bhd., yang merupakan pengeluar tunggal tempatan bagi keluli tahan karat gulungan sejuk telah menghentikan pengeluaran pada 30 Jun 2024.

(2) Kerajaan berpuas hati bahawa maklumat yang didapati itu mengandungi alasan yang mencukupi untuk memulakan suatu kajian semula pentadbiran.

Tatacara

5. Setelah menentukan bahawa keterangan yang mencukupi wujud untuk mewajarkan suatu kajian semula pentadbiran duti anti-lambakan berkenaan dengan import dagangan subjek, Kerajaan memulakan kajian semula pentadbiran menurut perenggan 28(1)(c) dan (f) Akta Duti Timbal Balas dan Anti-Lambakan 1993 dan peraturan 34 Peraturan-Peraturan Duti Timbal Balas dan Anti-Lambakan 1994.

Pengumpulan maklumat

6. Semua pihak berkepentingan dijemput untuk memberikan pandangan mereka secara bertulis dan dengan mengemukakan keterangan sokongan.

Had masa

7. Semua pihak berkepentingan hendaklah menyatakan pandangan mereka secara bertulis dalam masa lima belas hari dari tarikh penyiaran notis ini dalam *Warta* jika pandangan itu hendak diambil kira semasa kajian semula pentadbiran, melainkan jika dinyatakan sebaliknya.

Pengemukakan maklumat bertulis dan surat-menyurat

8. (1) Semua pengemukakan maklumat dan surat-menyurat hendaklah dibuat secara bertulis dan dihantar melalui pos, faksimile, e-mel atau serahan tangan dan dengan jelas menyatakan nama, alamat, alamat e-mel, dan nombor telefon dan faksimile pihak berkepentingan itu kepada—

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

NOTICE OF INITIATION OF ADMINISTRATIVE REVIEW OF ANTI-DUMPING DUTIES
WITH REGARD TO THE IMPORTS OF COLD ROLLED STAINLESS STEEL IN COILS,
SHEETS OR ANY OTHER FORM ORIGINATING OR EXPORTED FROM THE PEOPLE'S
REPUBLIC OF CHINA, THE REPUBLIC OF KOREA, CHINESE TAIPEI AND THE KINGDOM
OF THAILAND

(AD 01/17 – AR 03/24)

FOLLOWING the publication of the Notice of Affirmative Final Determination of Administrative Review of Anti-Dumping Duty with regard to the Imports of Cold Rolled Stainless Steel In Coils, Sheets or Any Other Form Originating or Exported from the People's Republic of China, the Republic of Korea, Chinese Taipei and the Kingdom of Thailand [*P.U. (B) 290/2023*] in the *Gazette* on 25 July 2023, the Government has obtained information for an administrative review on the imposition of an anti-dumping duty with regard to imports of cold rolled stainless steel in coils, sheets or any other form with thickness between 0.3 millimetres to 6.5 millimetres and width more than 1,600 millimetres, excluding—

(a) cold rolled stainless steel with bright annealed (BA), No. 8 (Mirror Finish), embossed, rigidised, etched or coloured finishes; or

(b) cold rolled stainless steel with hardness value of more than 250HV,

originating or exported from the People's Republic of China, the Republic of Korea, Chinese Taipei and the Kingdom of Thailand ("subject merchandise") and pursuant to paragraphs 28(1)(c) and (f) of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and regulation 34 of the Countervailing and Anti-Dumping Duties Regulations 1994 [*P.U. (A) 233/1994*], the Government initiates an administrative review on the imposition of anti-dumping duties on the subject merchandise.

Subject merchandise

2. (1) The subject merchandise is classified under the Harmonised System Code ("H.S. Code") and ASEAN Harmonised Tariff Nomenclature ("AHTN") 7219.31.00 00,

7219.32.00 00, 7219.33.00 00, 7219.34.00 00, 7219.35.00 00, 7220.20.10 00 and 7220.20.90 00.

(2) The H.S. Code and AHTN specified in subparagraph (1) are given only for information and have no binding effect on the classification of the subject merchandise.

Existing anti-dumping duties

3. The anti-dumping duties currently in force on the subject merchandise are definitive anti-dumping duties imposed under the Customs (Anti-Dumping Duties) (Administrative Review) Order 2023 [*P.U. (A) 225/2023*].

Grounds for administrative review

4. (1) The initiation for administrative review is based on the grounds that the company Bahru Stainless Sdn. Bhd., the sole local producer of cold rolled stainless steel, has ceased production on 30 June 2024.

(2) The Government is satisfied that the information carries sufficient grounds to initiate an administrative review.

Procedure

5. Having determined that sufficient evidence exists to warrant an administrative review of the anti-dumping duties with regard to the imports of subject merchandise, the Government initiates an administrative review pursuant to paragraphs 28(1)(c) and (f) of the Countervailing and Anti-Dumping Regulations Act 1993 and regulation 34 of the Countervailing and Anti-Dumping Regulations 1994.

Collection of information

6. All interested parties are invited to make their views known in writing and by providing supporting evidence.

Time limit

7. All interested parties shall present their views in writing within fifteen days from the date of publication of this notice in the *Gazette* if such views are to be taken into consideration during the administrative review, unless otherwise specified.

Submissions of written information and correspondences

8. (1) All submissions of information and correspondences shall be made in writing and sent by post, facsimile, e-mail or by hand and with clear indication of the name, address, e-mail address, and telephone and facsimile numbers of the interested parties to—
