**Subject: Disclosure of the essential facts for the draft final determination of an expiry review of anti-dumping measure concerning imports of cold reduced carbon steel in coils and not in coils originating in the People's Republic of China, the Socialist Republic of Vietnam and Chinese Taipei**

The Department of Foreign Trade ("DFT") presents its compliments to the Embassy of the Socialist Republic of Vietnam and has the honor to refer to the DFT letter No. 0309/c 234 dated 27<sup>th</sup> January 2025 informing the initiation of an expiry review of anti-dumping measure concerning imports of cold reduced carbon steel in coils and not in coils originating in the People's Republic of China, the Socialist Republic of Vietnam and Chinese Taipei, announced in the Royal Thai Government Gazette on 23<sup>rd</sup> January 2025.

In this regard, the aforementioned review is now approaching the stage of final determination. The DFT hereby disclosed essential facts for the draft final determination of an expiry review of anti-dumping measure which form the basis for determination (section 3.2.1). All interested parties are hereby provided an opportunity for written submission of comments regarding the disclosure and submit to the DFT no later than 6<sup>th</sup> October 2025, 4.30 p.m. Bangkok Time.

In addition, interested parties who may request to be heard orally shall register their name(s) of the person(s) (maximum of two) who are likely to attend the hearing (Section 3.2.2), together with written oral statements to the DFT no later than 6<sup>th</sup> October 2025, 4.30 p.m. Bangkok Time. In case there is a request to be heard orally, the DFT agrees to arrange the requested hearing on 9<sup>th</sup> October 2025, 10.00 a.m. at Conference room no. 1601, 16<sup>th</sup> floor, the Department of Foreign Trade. Kindly refer to QR code attached for relevant documents and rules of hearing procedure (section 3.2.3).
